These conditions of participation apply to all events organized by www.mugiucentras.lt, unless otherwise stated, for participation in a specific event.

2. PARTICIPANT APPLICATION

- Participant of the event registers to the fair by completing the registration form, which is available on the website www.mugiucentras.lt/Registration. Registration can be made as long as the selection of the event is active.
 - Requests submitted later may be granted only when available.
 - The participant, when submitting an application, indicates a full range of products. In the event of a mismatch in the event, the participant may be removed from the event without refunding the participation fee.
 - The application, filled in electronically, has legal force and is considered as a participant's decision to attend the fair.
 - The organizer of the fair reserves the right to select the participants according to the range of products and their quality.
 - Refusal to participate in the fair is possible on the basis of the "Refusal to Participate" section of these Conditions.

3. PARTICIPATION FEE

- The cost of participating in the fair is indicated at www.mugiucentras.lt/Registration for each event.

4. PAYMENT CONDITIONS

- A participant of the fair, **after receiving the registration confirmation**, must pay for the event within 5 calendar days.
- A participant who has registered less than 5 days prior to the event must pay for the event before the event starts.
- Invoices are issued after the event and sent to the participant's e-mail that is stated in the participation form.
- Payment details are available at www.mugiucentras.lt/Registration.

5. REFUSAL TO PARTICIPATE OR ARRIVE

- Refusal to participate in the fair must be submitted in writing and is valid only after approval by the organizer.
 - The Participant is entitled to receive 80% of the amount paid if he submits a written request at least 11 days prior to the event.
 - The paid amount is not refundable if you submit your request 10 days before to the event.

- You can only sell a place to a third party with the consent of the organizer.

6. PARTICIPATION ORDER IN THE FAIR

- The participant of the fair must occupy only the area devoted to him and has no right to go outside it, thus hindering other participants of the fair.
- Keep the place clean, leave the place tidy after the event.
- There are cardboard containers and also garbage containers in the area.

If you leave your place untidy and leave your rubbish after the event you will be fined **up to 50 eur.**

- It is prohibited to use alcohol and other substances during working hours at the fair.

Attention! It's not always allowed to drive cars to the fairgrounds. The organizer of the fair provides this information along with the general information before the event.

7. SAFETY

- Fairs are not protected unless the organizer of the fair informs about it individually.
- In each case, each participant takes care of the safety of his stand.

8. PLACEMENT APPOINTMENT PROCEDURES

- Participants' places are distributed by the organizer, taking into account the range of products indicated in the application.
- The appointed placement is based on the size indicated in the application. Non-standard places are coordinated individually.
- The list of placement of the participants is presented before the event.
- The places are marked in the fair territory, unless weather conditions or other factors, outside the organizer of the fair, allow for this.
- The event organizer reserves the right to change the placement of the participant to another area of the same size.

9. OTHER CONDITIONS

- **The organizer provides the placement list, arrival information and other important details of the event to the e-mail indicated in the application before the event.**
- The participant must provide to the organizer and have during the event all the documents proving the professional activity (business certificate, individual activity certificate, company employee's certificate, etc.).
- Food and alcohol drink sellers, must have valid hygiene passports and licenses.
- First time participant must submit the documents. Frequent participants, unless requested by the organizer, submit documents only in cases where the activity or the updated document no. changes and etc.
- **The Participant is liable for violations of public order and failure to comply with other legal acts in accordance with the procedure established by the laws of the Republic of Lithuania.**

10. DISPUTES

All disputes are negotiated. In case of disagreement between the parties, disputes are resolved in accordance with the procedure provided in the laws of the Republic of Lithuania, Vilnius City District Court.
